THIS AGREEMENT made and entered into this _____ day of _____ 20____ between _____ (PROMOTER) of the City of _____ and the state of _____, a licensed promoter of Pennsylvania, and _____ (BOXER) of the City of _____ and the state of _____, a licensed boxer in Pennsylvania.

WITNESSETH: BOXER agrees to enter into a boxing contest to be held at _____ (club) on the _____ day of _____ 20____ in the City of _____ and the state of _____ for _____ rounds, to a decision with _____ of the state of _____.

The weight for this contest shall be _____ pounds. (Give or take one pound - except for Championship bouts) Weigh-ins for this contest shall be held at _____ o'clock at _____ in the city of _____ on the _____ day of _____ 20____.

PROMOTER agrees to pay the BOXER and the BOXER accepts as in full for all his claims and demands for and on account of the performance by him of this contract the **SUM of \$ _____ DOLLARS** and other **EXPENSES** as follows: _____

IT IS UNDERSTOOD AND AGREED that said contest shall be with gloves that are approved by the Commission and furnished by the PROMOTER. All officials of the contest shall be persons licensed by the Commission. If the Commission shall decide that the BOXER did not enter into this contract in good faith, or is not honestly competing, or is guilty of an act that is detrimental to boxing, it is agreed that the BOXER shall not be entitled to the compensation listed above or any part thereof, and that such decisions of the Commission shall be final.

The BOXER hereby agrees to deposit with the Commission, cash or other accepted draft for the sum of _____ dollars, as forfeit money, to guarantee his appearance, his making the agreed upon weight and for his performance of this contract in all other respects. If BOXER shall fail to appear or make weight or is not in physical condition to box as determined by a duly licensed physician, then said forfeit money, as determined by the Commission, shall be distributed to the aggrieved parties. The Commission reserves the right to fine, suspend or take any other reasonable action against such BOXER.

IT IS UNDERSTOOD AND AGREED that if the boxer enters into another contest prior to the one contracted for and lessens his present value as an attraction, the PROMOTER shall have the option to modify or cancel this contract. The Commission reserves the right to fine, suspend or take any other reasonable action against such BOXER.

IT IS UNDERSTOOD AND AGREED that the PROMOTER is to make all necessary arrangements for said contest.

IT IS UNDERSTOOD AND AGREED that all parties to this contract hold valid licenses with the Commission.

IT IS UNDERSTOOD AND AGREED that in the event of any dispute arising from this contract, the Commission may intercede in said dispute and all decisions rendered by the Commission shall be binding on all parties.

IT IS UNDERSTOOD AND AGREED that this contract must be given to the Commission before the start of weigh-ins. This agreement is subject to the provisions of the Boxing Act of the Commonwealth of Pennsylvania and to the rules and regulations of the State Athletic Commission of Pennsylvania and to any future amendments of either of them. ** Boxer must have Negative HIV exam and current Federal I.D. Card to compete.
